5. Diploma examination results for 2012-13 have been restated to include additional diploma examination rewrite results.
6. Seventeen additional questions were added to this measure and the historical results were revised in 2012-13. Results for 2009-10 do not include responses to the new items from the public respondent group and caution should be exercised when comparing results.
7. Historical results from 2009-10 to 2011-12 are based on a lower sample size for corresponding respondent groups. Caution should be exercised in comparing results from these years to current results.

Significant difference is considered in assessing trends and target achievement for all measures. Targets are considered met if the current result is not significantly different from the target value.
