

Establishing a Private School Application Process

Background

The Government of Alberta respects choice in education, including private schools. The application process is described below for those who wish to establish a private school in Alberta.

Application Process

Formalize your organizational structure

Private schools are governed under a variety of organizational structures. In order to be eligible for funding, an accredited private school must be incorporated as a society under the [Societies Act](#) or registered as a non-profit company under Part 9 of the [Companies Act](#) or operate under a special Act of the legislature. Each private school must operate in accordance with its approved bylaws.

Become familiar with Alberta Education's application process, Annual Operating Plan and requirements

For best results, begin your planning in the winter months for submission of your application by March 15.

Submission of Annual Operating Plan

Fact Sheet Contents Types of Private Schools

Determine the type of private school you wish to establish and the programs you will offer

Section 28 of the [School Act](#) authorizes two kinds of private schools to operate in Alberta: registered and accredited. Please see page 2 for further details.

Notify Alberta Education of your intent to establish a private school and submit the application form.

Contact School Accreditation and Standards Branch of Alberta Education at 780-427-7235 about your intent to establish a private school, and branch staff will provide information and appropriate notification forms.

Receive Alberta Education's decision

Alberta Education will notify the private school regarding the status of their accreditation.

Expect Alberta Education to monitor the private school

In the first year, an Alberta Education manager will meet with the private school operator to monitor the school for compliance with Alberta Education requirements. There is no set timeline for when that visit will take place, but the manager will provide adequate notice of the monitoring visit.

Types of Private Schools in Alberta

Registered private schools, defined under Section 28(1) of the [School Act](#), must meet basic registration requirements set out in the [Private Schools Regulation](#). The requirements are set out on the chart on the following page. Registered private schools are not eligible for Alberta Education funding.

Accredited private schools, defined under section 28(2) of the [School Act](#), must continue to meet the requirements of a registered private school; however there are additional requirements set out in section 28(2) of the [School Act](#) and in the [Private Schools Regulation](#) that must be met in order to receive accredited status. These requirements are noted on the following pages.

Accredited non-funded private schools are primarily those private schools that focus on adult education, language and culture. These schools are not eligible for Alberta Education funding.

Accredited funded private schools are entitled to partial provincial funding, pursuant to the Minister of Education's authority to make grants under the [Government Organization Act](#) and the [Education Grants Regulation \(AR 120/2008\)](#). However, accredited funded schools must operate for one year with no government funding ([Private Schools Regulation](#) section 9(1)). Refer to the most recent [Funding Manual for School Authorities](#) for details on applicable funding rates.

Designated Special Education Private Schools provide education programs only to students with a mild, moderate or severe disability. These schools receive special approval and funding from the Minister.

New Information for Designated Special Education Private Schools applicants

Established Designated Special Education Private Schools will be given annual approval once the Annual Operating Plan has been signed by School Accreditation and Standards Branch.

To be considered for status as a Designated Special Education Private Schools:

1. The private school operator must operate the school for one year without Alberta Education funding, if they are not already operating an existing accredited funded private school.
2. During the school's second year of successful operation and after approval as an accredited funded private school, School Accreditation and Standards Branch will conduct a Special Education Programming Standards Review to ensure that the school is offering appropriate programming.
3. Existing accredited funded private schools that request a change in status as a Designated Special Education Private School, will undergo a Special Education Programming Standards Review to ensure that the school is offering appropriate programming.

Heritage Language Schools do not fit neatly into either category. These schools offer language and cultural programming for students in ECS to Grade 12 and most do not receive funding from Alberta Education. If funding is received from Alberta Education, it is through the [Credit Enrolment Unit \(CEU\)](#) funding system for provincially authorized or Locally Developed/Authorized high school courses, if CEU accountability requirements are met.

Programming Considerations

A special education program must be offered in any private school that admits a student with special needs. Private school operators should provide appropriate student programming.

Early Childhood Services (ECS) programs may be offered by any private school operator. The private school operator must meet the requirements set out in the [Early Childhood Services Regulation](#), including offering a Kindergarten program that complies with the [Kindergarten Program Statement](#). Funding is available from the first year of operation, and operators are expected to provide access to a minimum of 475 hours of instruction.

Home Education is a program of choice whereby a parent provides a home education program to a student under the supervision of an associate board or associate private school. Under the [Home Education Regulation](#), the parent is responsible for developing, administering and managing the home education program. The associate board or associate private school also has responsibilities.

Only an accredited funded private school may be an associate private school.

A blended program is an educational program that consists of two distinct parts:

- (1) a school-provided program where a teacher employed by a school board or an accredited funded private school is responsible for providing the planning, resource selection, instructional delivery, assessment and evaluation of student progress in selected courses that follow the [Alberta Programs of Study](#); and
- (2) a home education program that meets the requirements of the [Home Education Regulation](#), including supervision by an associate board or associate private school.

Regulations

Regulations are legal requirements that derive their authority from specific sections of various acts. Most regulations that apply to private school operators are made under the authority of the [School Act](#) and the [Government Organization Act](#).
