## Full exemption

## **Partial Exemption**

When a student is exempted from either Part(ie) A or B of a Language Arts or Social Studies exam, a different method is used to replace the missing mark. A mark that is statistically estimated (based on their performance on the part of the exam which was written and the school awarded mark) will replace the missing mark.

Following a partial exemption, if a student chooses to improve their diploma exam mark, the entire diploma exam needs to be rewritten.
